Frank Schneider Jr. International Muskie Tournament – 2003

The Twin Cities Chapter 36th Annual Frank Schneider Jr. International Muskie Tournament will take place September 5th, 6th, and 7th on lakes in the Walker, Cass Lake, Bemidji, and Longville areas.

The Grand Prize this year is a Ranger 618VS Fisherman, powered by a 125 hp Mercury with a Minn kota Maxxum trolling motor, equipped with Garmen electronics. The Grand Prize is awarded at the Sunday Banquet by draw from the names of every angler who registers a fish in the tournament.

Entry fees are \$60.00/adult and \$30.00/junior. Tickets go on sale August 1st at Thorne Brothers in Fridley, Joe's Sporting Goods in St Paul, Reed's Sporting Goods in Walker, and Jerry's One Stop in Longville. Tickets will also be available at the August Annual Picnic meeting. If you want to order tickets by mail, use the order form included in this issue. Make copies if you are purchasing more than one ticket. You can also order tickets online at www.twincitiesmuskiesinc.com.

Two Friday night feeds have been scheduled, one at Canal House Restaurant at Stony Point and the other at Fireside Inn, on Highway 200 on Leech Lake, for those who want to join fellow fishermen for an evening meal. Cost for the feed is \$12.00/person in advance. The Sunday Banquet and Awards Ceremony will be held at Walker City Park.

Prizes will be awarded thru 10th place in the Release division, thru 3rd place in the Junior Release division, 1st and 2nd place in the Northern division, and 1st place for the Weight division.

Participating in the International Tournament is an excellent way for you to support our chapter. This is our biggest fundraiser of the year. The money raised from this event will cover about half of our 2004 budget.

If you have fished this tournament before, you already know how much fun it can be. We hope to see you there. It will be a great time.

Canadian Opener at Manitou Lake System

In the final week before the Manitou outing, a helicopter crash and an eye surgery dwindled the group from six to three. Greg Ide, Clark Mattson, and Chris Cochran from the North Metro chapter made the trip to the 50-mile long Manitou Lake system in late June for the Canadian opener.

So the group boating in to Barker Bay Outpost was small but enthusiastic. They needed to be, as the Manitou is immense, with endless spots to fish, and few other fishermen to learn spots from.

The Manitou has fine season-long fishing with 50-plus-inch fish caught from June through October. A few of the Manitou's famous big ones were spotted, but none were caught during the week. The largest *Esox* caught was, in fact, a pike – a 42" monster – over 20 pounds, caught by Chris. A total of eleven muskies were boated – the largest at 40" caught by Greg. A notable day was spent lake trout fishing on a hike-in lake, where several trout up to 15 pounds were caught and released.

Trip Won in Raffle Nets First-Ever Big Fish

Last year one of the trips won at the Project and Rearing Fund Raffle was a week-long trip to Shingwak Resort on Whitefish Bay, Lake of the Woods won by Stu McIntosh. He was unable to schedule a trip last year, but this spring he and three friends, Chris Mueller, Ryan Buboltz and Jay Kalsbeck went for the Canadian opener.

The trip provided a number of first-ever experiences for Chris. This was his first-ever muskie fishing trip in Canada, and he got his first-ever 50 inch muskie. The fish was caught at 10:50 am on June 23rd and was expertly netted by Stu. It measured 52-1/2 inches with a girth of 24 inches. This is the biggest fish turned in for the Members Only Contest so far.

“Get Off Your Dead Butt and Go Fishing!”

That's advice from Stan Koich, one of the “Capable Partners” with whom our chapter shares a June day every spring. For years now we've been taking those physically challenged but exceptionally eager Muskie anglers out for a morning of fishing on Lake Independence followed by a great shore lunch. This year my buddy Jim Baker and I had the special pleasure of fishing with Stan, whose picture graces the cover of the 2003 Muskies Inc. calendar.

Stan wants to catch a Muskie, you see, he really does. This was his fourth year out after them, and he's still looking for his first one. But you can also see that when he finally gets it – check out those outstretched arms on the calendar – it's going to be a lunger.

Stan fished seriously and without a rest, casting a full assortment of jerk baits, surface lures, and bucktails. And indeed, he wore me out. By mid-morning I had to quit and go back to the boat launch, sit in the shade of a tree, and watch the boats out on the lake. But Stan had Jim take him back out for another couple of hours.

So Stan certainly followed his own advice that day. But like all the Capable Partners members, he does more than fish – you can't accuse him of “sitting on his butt.” He works full time in Child Support Enforcement for the state, has three kids of his own, all of whom fish, and has been in Capable Partners since 1987. He's an avid walleye fisherman, a goose hunter, and goes after deer too. But he's not yet a “Muskie Catcher,” even though he's netted them for others. His parting words as we were leaving? “I'll get one next year.” And I believe he will.

Besides Stan, we had the standard dozen or so Capable Partners folks in



attendance, as well as our regular crowd of Muskie Incers. And I've got all the usual pictures and stories. Let me just note that Tom Lund was on duty once again as chief cook. But this year Tom also had a nasty problem when his trusty Johnson motor on his Yar-Craft didn't start, and he had to go all the way around the lake on his trolling motor. (Only later did Tom realize that

the “cut out” plug had pulled loose from the dash – let that be a lesson for all of us.) But Tom didn't get any fish with all his electrical troubles.

Did anybody else catch anything? I polled the boats as they came in, and it wasn't a total skunk. Joe Demars and Denny Heath reported a bass and a 4 lb. northern. Doug Ivie reported five

Members Only Contest

WOW!!! As of July 15, I have entered 103 fish ranging from 30" to 52.5" that were released by 31 members. This exceeds last year's record of 21 people and 65 fish. I love getting all these release forms in the mail and at the meetings!

Hot local lakes include Waconia where Steven Wohl has nine releases. Matt Olson also released a fish on Waconia as well as one on Leech Lake. Minnetonka has yielded 12 fish including a 49.25" for Tony Sommerfeld and a 50" for Jim Doyle. Mark Sewald has released four fish on Lake Independence with 47.5" being the longest and three on Big Arbor Vitae, WI. Lonny Hess, John Olson and Duff Thury have all released muskies on Bald Eagle. Duff Thury has also released four fish on Harriet with the longest being 48".

Junior member Evan Nicolai released a 48" muskie on Cass Lake on June 14 and Bob Culbertson has released five fish on Baby Lake. Big Detroit and Big Mantrap were good choices for Scott Eckert and Greg Pirritano released his fish on Big Lake. Jeff Melton spent a week on Little Wolf and released nine fish ranging from 36" to 42". Jeff also has three releases on French Lake.

Sharon and Chris Swentkofske have been fishing a lake or lakes in Aitkin Country with good results – four fish. Tony Walman has released fish on Elk Lake, Minnetonka and Rowan Lake, Ontario, Canada.

Brian Hanson also went to Canada and released two muskies on Rough Rock and one on Little Sand. Elaine and Greg Randolph each released a muskie on Eagle Lake. But the big news comes from Lake of the Woods. John Olson released three fish on Whitefish Bay but they weren't as big as Chris Mueller's 52.5" on June 23. Turk Guderjan released a 48" on June 30 and Todd Doebler released a 50.5" on June 25. Lois and Tom Harvey spent a few days on Sabaskong Bay where Lois released muskies of 36", 41.5" and 48.5".

The PATCH and CERTIFICATE area is missing on the entry forms that were printed earlier this spring but added to the web version. If you are using the printed forms available from me or at the meeting, please note on your form if you want a patch, individual certificate or annual certificate.

Remember, entry forms must be postmarked within 30 days of the catch. Several fish have already been disqualified this year. Don't let it happen to you!

Successful Releases

Releasing a muskie is one way to ensure it grows to its true potential. Two easy rules to remember for a successful release are: baits can be replaced – muskies can't; and never keep the fish's head out of water longer than you can hold your breath.

Make the release quick. Have the right equipment readily available. When holding the fish, support the belly with one hand and the tail with the other. After a quick photo, place the fish back in the water and work it slowly back and forth. Remember, never fight the fish longer than necessary, minimize its time out of water, and handle the fish as little as possible.

follows and one hit. John Olson lost a northern but didn't see any muskies. Libby and Tim Hoene saw a couple and had a couple of strikes, and then spotted a forty-incher right next to the dock as they were coming in (it didn't hit). Steve Hedensten mostly trolled, to no avail. And a couple of the other boats came back with similar stories.

However, there were two noteworthy catches. First, as our boat was working that underwater bar on the southwest side, we spotted another boat – not one of ours – with a fellow in a fierce battle with a fish. His rod was bent, the fish stayed down, the line was zinging through the water, a beautiful sight! We came in closer, being careful not to get in the way, and watched the fight all the way to the end, as he finally subdued and brought in the 10 lb. carp. I've got pictures. (He released it.)

But who of us did get a real fish? Paul Hartman, out with his regular boat buddy, Rod Guthier, the organizer of the event. Paul hooked into a mid-30s muskie and immediately handed the rod to Rod, who brought the fish in. That was Rod's first muskie, after many, many outings. And of course, like Stan and the rest of the Capable Partners folks, he's talking about the big one that he'll get next year.

So that's Capable Partners for 2003, the last of our chapter's three annual spring events – Vet's Home, the Kid's Outing, and CP. I've been to all of them and written about them now for the last couple of years. I'll close with my usual note: Join us next year. I can't promise you a muskie, and really not a carp either, even though I've got that hotspot marked, but I do promise you the best and most rewarding things that Muskies Inc. has to offer.

Kid's Fishing Contest

Don't forget to keep track of your children's catches this season and enter them in the Chapter Kids Only Fishing Contest. The rules are simple. 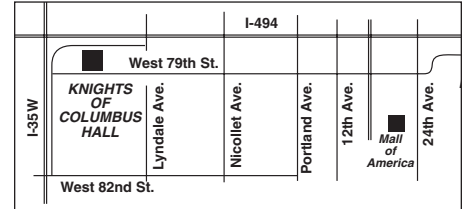
