## Smokey Swenson Benefit Auction a Success

For those of you that could not attend the Twin cities chapter December meeting – a Benefit-Auction for Smokey Swenson – you missed what was truly a moving night. The meeting started with a quick election of the board of directors and officers. From that point on it was a mixture of bidding wars at both a live auction and silent auction tables. Events such as this prove that Muskies Inc. is much more than just a fishing club – it's small-town America right here in the big city – and it's showing a friend how much you care with actions rather than words.

After first visiting Smokey in intensive care at North Memorial Hospital early this October it became apparent this would be a long, expensive recovery for him. When the fundraising efforts started, I was hoping we could break the \$8,000 mark, but never anticipated we would raise nearly double that – a total of \$15,700!

Paul Villnow logged countless hours on the Internet keeping muskie anglers from Hopkins to Holland abreast of the club's efforts and Smokey's current condition. This brought in an impressive amount of donations of both cash and auction items. The night of the auction the committee was scrambling to mark and display all of the additional donations that kept coming through the doors with attendees.

The benefit-auction lasted until 11:00 pm with Matt Thompson from Thorne Bros. auctioning off item after



item. Perhaps Matt summed up the feeling of the evening best when he observed "this is not lets-get-a-bargain night... it's time to dig deep into our pockets and help a friend in need."

The nearly 200 in attendance spent an average of \$90 each and most stayed until the very end of our record latest-running meeting. Smokey, who surprised a lot of us by showing up, struggled to remain composed while speaking to the group, calling the benefit-auction the "most overwhelming event of my life."

There are too many people who donated items for the auction to possibly mention everyone. However, I especially want to mention Thorne Brothers, who gave as their contribution nearly \$2900 in products to auction for only \$900. Many individuals gave cash donations with 11 giving \$100 each. Red Wing Lodge supported an life-long guest by donating a one-week trip for 4 anglers next September. Many fellow guides donated trips, and Tony Grant included a week lodging with his

outing. The entire donation list will be on the welcome table at our January meeting.

Patti Slack spent hours organizing before and at the auction while Greg and Elaine Randolph and Terri DuBe kept it all together at the cash register. Finally, I personally want to thank every person in the room that night for giving so freely to such a dear friend. Any additional donations can be mailed to: SMOKEY SWENSON'S BENEFIT, P.O. Smokey's stroke and heart attack occurred in early October and his slow, rocky road to recovery will return him home early in the new year. The outpouring of sympathy and support the past months was inspiring and helped fuel Smokey's drive to recover. There is still much progress to be made, but I look forward to fishing with Smokey again in Iowa's 3rd Annual "Spring Tune-up Tournament" in late April. He has vowed to spend two straight weeks at Red Wing Lodge in August for our chapter outing and the Chapter Challenge.

We will continue to push Smokey in his recovery as Muskies Inc. expects at least another 20 years of service and dedication from him!!!

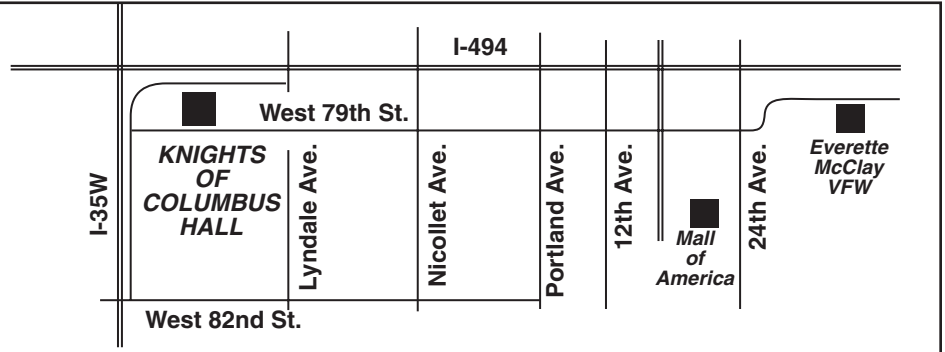
