ALL ENTRIES for the 2003 Contest were DUE JANUARY 3, 2004! Hopefully, everything has been entered correctly. If you detect a problem with your entries, please contact me immediately.

As we start a new season – for some of us that will be just a few months – remember the required information on your release form:

- 1) The State or Province,
- 2) The Lure type and
- 3) The Name of the Lake or River.

“NO EXCEPTIONS!”

At this time I have no further information on members entering their own release forms into the Lunge Log. Trust me – I will let everyone know when this becomes available.

When you think muskie fishing in November on Mille Lacs, think Brian Hanson. His eight releases include a 43", a 41", a 50" with a 25" girth, two 45"s, a 52" with a 26" girth, a 50" with a 24" girth and a 46". WOW! That's 164 points in one month!

Minnetonka was popular in November – Tom Batina and Tom Becker both released 39" muskies, Jim Doyle released a 38", a 44.5" and a 49.25", and Tony Sommerfeld released a 45" with a 21" girth.

Gary and Richard Wolff spent three days in November on Leech Lake freezing in single digit temperatures but were rewarded for their efforts. Gary released a 43" and a 49.5" with a 25" girth and Richard released a 52" with a 26" girth.

Bob Culbertson released 4 fish on October 18 and 1 on October 25 prior to closing his cabin on Baby Lake. He finished the season with 24 fish – 262 points – and all but 4 from Baby Lake.

This about wraps the members only contest up for another year, except for the big event. The presentation of the plaques to all the winners and graphic reproduction of the longest release of the season will happen at the Winter Picnic on February 21. This is an event you won't want to miss!

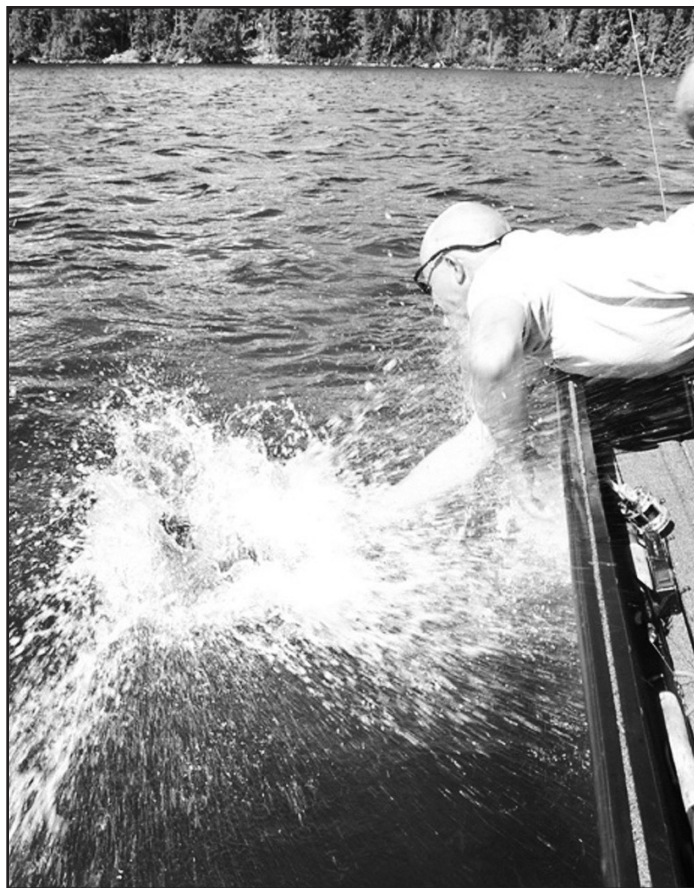

DNR Reviews Spearing Regulations

Recently George Selcke, on behalf of the Twin Cities Chapter of Muskies Inc, sent a letter to the Director of the Fisheries Division of the MN DNR stating the chapter's position concerning northern pike spearing regulation changes under review by the DNR. Rule changes being considered will be determined by March 2004 and will become permanent at that time.

The chapter is opposed to the DNR recommendation of dropping Dumbbell Lake (Lake County), Cedar Lake (Scott County) and Lake Owasso (Ramsey County) from the lakes with northern pike speaking bans. The chapter would like to see both Cedar and Owasso to be designated muskie lakes.

The chapter also suggested to the DNR that both Lake Vermillion and the Mississippi River be added to "designated waters".

George stated he would have liked to include other groups with the recommendations put forth in the letter. However, the MN Muskie Alliance, a group formed last year to include groups state-wide with interests in muskie fishing and conservation, is still having "growing pains" and has not yet been able to form a group to address this issue.

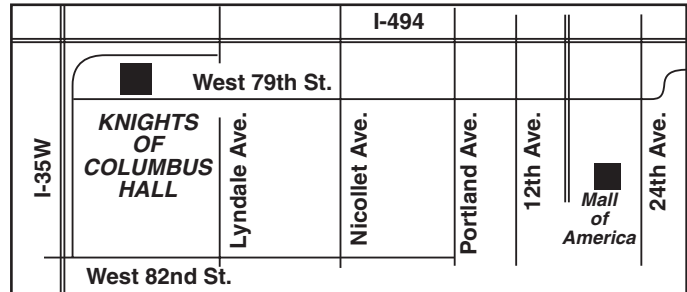

The Knights of Columbus Hall in Bloomington is located just south of I-494 on West 79th Street just off Lyndale Avenue South.

To get there from I-494, exit at Lyndale Ave., turn south to the first light (W. 79th St.) and turn west (right). The KC Hall is about three blocks on the right side.

From I-35W you can exit at 82nd St., follow the east frontage road to 79th St. and turn east (right). The KC Hall is on the left. Or take 82nd St. east to Lyndale, turn north (left), go to the first light at 79th St. Turn west (left) and proceed to the hall.
