2004 Frank Schneider, Jr. International Tournament

he Twin Cities Chapter 37th Annual Frank Schneider Jr. International Muskie Tournament will take place September 10th, 11th, and 12th on lakes in the Walker, Cass Lake, Bemidji, and Longville areas.

The Grand Prize this year is a Ranger 618VS Fisherman, with a 125 hp Mercury and Minn kota trolling motor, and a one-week stay at Birch Villa Resort on Cass Lake. The Grand Prize will be awarded at the Sunday Banquet in Walker City Park by draw from the names of every angler who registers a fish in the tournament.

Entry fees are \$60.00 for an adult ticket and \$30.00 for a junior. Tickets are on sale until 9:00 pm on Thursday September 9 at Reed's Sporting Goods in Walker, and Jerry's One Stop in Longville. No tickets will be sold after 9:00 pm on Thursday, September 9.

Every contestant participating in the tournament must wear their tournament hat while fishing. Tournament hats can be picked up on Thursday, September 9, at Reed's Sporting Goods or Jerry's One Stop in Longville.

This is not a team event. Each individual who catches a fish, enters the fish for him/her self. The fish must be witnessed, but the witness doesn't have to be a boat partner.

The Awards Banquet will be held

on Sunday, September 12 at approximately 1:00 pm. Prizes for the top ten places, top juniors and top northern will be awarded. A drawing of all those who witnessed fish will be held and there will be lots of door prizes for those who may not have made the top ten. And, of course, the drawing from all persons who caught and registrered a muskie, for the Grand Prize boat, motor, trailer, resort stay package.

Participating in the International Tournament is an excellent way to support our chapter. This is our biggest fundraiser of the year. If you have fished this tournament before, you already know how much fun it can be. We hope to see you there. It will be a great time.

The forms completed for the tournament stay with the Tournament Chairperson and are not forwarded to me.

Evan Nicolai added to his Junior Division lead with a 39" release on Inguadona on 7/16 and a 42.5" release also on Inguadona on 8/7. Not to be outdone by her big brother, Dallas Nicolai released her very first muskie – a very respectable 44" – on July 30 on Ingudona. Having his picture in last month's "On the Water" holding a very nice bass must have brought JT Doebler some luck. The 6 year old released a 30.5" muskie on Cedar Lake, MN on July 31. Congratulations to all our junior members!

The new leader for August is Tom Harvey with a 52" release on August 2 from Lake of the Woods. Tom caught this fish on a black Bucher Tail. Don Pursch released a 50" and a 51" on Rowan Lake in July.






