*For years, the Twin Cities Chapter and Paul Hartman's Tournament trail have been rearing muskies in various ponds leased or owned by Frankie Dusenka, of Frankie's Marine and Live Bait. Frankie's has donated time, equipment, feeding minnows and ponds to the projects. The North Branch pond featured on the cover of the December 2005 issue of MUSKIE magazine has now produced thousands of fish, with hundreds between 22 and 34 inches stocked into White Bear Lake. Muskies fry used to stock these ponds come from the Minnesota DNR. On January 27, 2008, a group netted the Scandia pond shown here through the ice. The pond had been netted in the fall, but the net developed a hole which allowed the young muskies to escape. Left: Greg Kappas with one of the netted muskies. 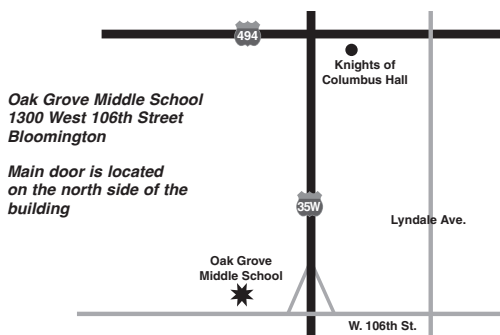

## **Minnesota Muskie Expo March 7, 8, 9**

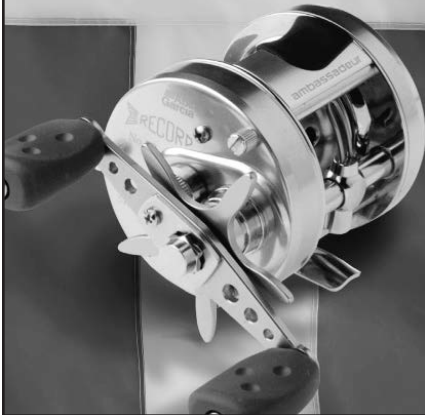

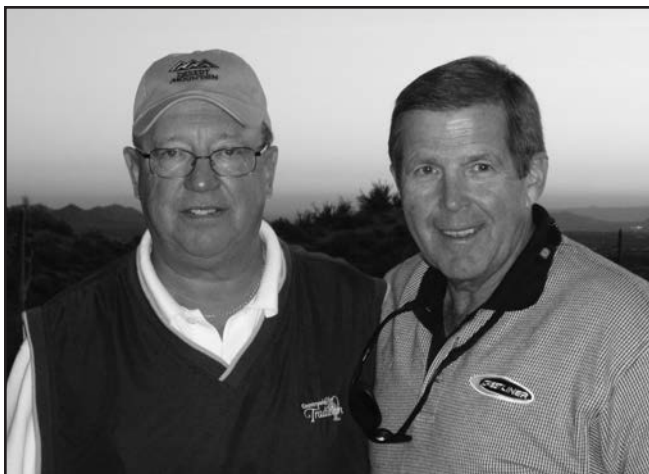
